This collaboration is described as a 'value-added joint effort' because it complements technical and procedural reforms with essential human resource support. Rather than treating mental health as an afterthought, UNDP and the PGO are elevating it to a core priority. Such an approach is expected to yield long-term benefits for the criminal justice system by ensuring that prosecutors and staff can serve the public with clarity, dedication and empathy.
